He has also been the catalyst for the "Nurturing Community Coalition" project taking root along the Southern Oregon Coast. He has trained over 300 local professionals and community members in Nurturing Programs. Child Care providers play a vital role in "Nurturing Communities" because their homes, centers and preschools are sites where school readiness can be implemented.
